

Regional Chief Administrative Law Judge Aaron Morgan is realigning the White Plains hearing office service area secondary to that office's closure in May 2025. Hearing request receipts will be shifted between hearing offices in metro New York and Connecticut in order to balance processing times among those offices absorbing the White Plains hearing office caseload. Under the new alignment:

- All claimants who currently are in the service areas of the New Rochelle (128), Peekskill (B93), and White Plains (148) field offices will be serviced by the New Haven, CT hearing office (Y05).
- All claimants who currently are in the service areas of the Middletown (118), Monticello (154), Poughkeepsie (133), and West Nyack (149) field offices will be serviced by the Bronx, NY hearing office (X36).
- All claimants who currently are in the service area of the Yonkers (113) field office will be serviced by the New York, NY hearing office (X82).
- All claimants who currently are in the service areas of the North Bronx (132) and West Farms (C77) field offices will be serviced by the New York, NY hearing office (X82).
- All claimants who currently are in the service area of the Brooklyn Bushwick (135) field office will be serviced by the New York, NY hearing office (X82).
- All claimants who currently are in the service areas of the Bedford Heights (160) and Brooklyn New Utrecht (137) field offices will be serviced by the New York Varick, NY hearing office (X69).
